Item No. 15.03: To consider and approve the Regulations, Examination Scheme and Syllabus for the B.Tech (CSE, ME, CE, EE), M.Tech(CSE, ME,CE,EE), BCA & MCA programmes run by the Department in accordance with Choice Based Credit System (CBCS) Scheme w.e.f the Academic Year 2015-16.

Resolution: The University Grants Commission vide D.O. No. F.1-1/2014 (Secy) dated January 20, 2015 had sent Guidelines to all the universities for implementation of Choice Based Credit System. The Vice-Chancellor had formed a Working Group to modify the syllabi of all the courses conducted by the University in accordance with the UGC Guidelines. The main thrust of the CBCS was to divide the course of a particular degree program into (i) Core courses (ii) Elective courses and (iii) Foundation courses. Also the Credit system is to be followed in all the courses. Accordingly several meetings of the Department Members of Engineering and Technology were held to suggest appropriate changes in the regulations, Examination Scheme and syllabi (**Annexure 15.03**).

The draft syllabi and Regulations have been placed in the Meeting of Board of Studies:

- A. The Detailed syllabi for B. Tech in Civil Engineering, B. Tech in Computer Science and Engineering, B. Tech in Electrical Engineering and B. Tech in Mechanical Engineering with effect from the academic session 2015-16 have been considered and RECOMMENDED to Academic Council for APPROVAL.
- B. The Detailed syllabi for B.C.A. and M.C.A. programmes with effect from academic session 2015-16 have been considered and RECOMMENDED to Academic Council for APPROVAL.
- C. The Detailed syllabi for M. Tech in Civil Engineering, M. Tech in Computer Science and Engineering, M. Tech in Electrical Engineering and M. Tech in Mechanical Engineering with effect from academic session 2015-16 have been considered and RECOMMENDED to Academic Council for APPROVAL.
- D. The Detailed syllabi for Diploma in Electrical Engineering with effect from academic session 2015-16 has been considered and RECOMMENDED to

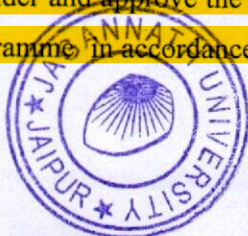
Item 15.1: To confirm the minutes of the Fourteenth meeting of the Board of Studies held on January 17, 2015.

- b. **Provide necessary infrastructure apart from classrooms such as hostel accommodations, food arrangements, equipped computer labs, library etc. payable as per University norms.**
- c. **The Jagan Nath University shall issue the Degree of the program as per UGC norms on successful completion of 2 years program.**
- d. **This programme is spread over 4 semesters out of which first 3 semesters are devoted for class room teaching and 4th semester is for Industrial Training.**
- e. **Jagan Nath University and TCLL will design the detailed course curriculum with mutual consultation which will be duly approved by BoS and Academic Council.**
- f. **TCLL will promote the program vide publications, print media, digital media etc.**
- g. **After the completion of first year the student shall be provided Placement assistance by TCLL which includes minimum. 3 job interviews for each Batc**

Item 15.5: To apprise the live projects done by MBA and BBA Students

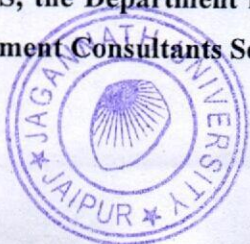
The committee was apprised about the live projects done by MBA-II, BBA-IV and BBA-VI Semester students during the semester under the initiatives of E-Cell

The strategy for implementation of Capabilities Enhancement Skills session for enhancing Employability of final year MBA and BBA students was discussed and approved.

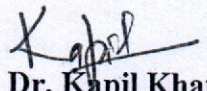
Item 15.11: To discuss detailed plans of action for the semester.

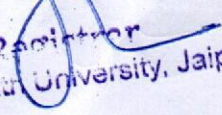

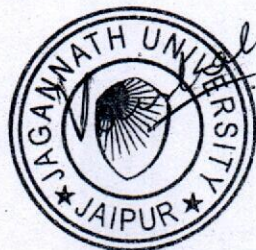
