The Vice-Chancellor welcomed the members to the Fourteenth meeting of the Academic Council. The Vice-Chancellor informed the members that the academic session 2011-2012 has been completed successfully. The examinations were held in months of June-July 2012 and all the results have been declared, well in time. The academic session 2012-13 has started and the admissions to the various courses are going on.

**Agenda Item 14.01:** The Academic Council confirmed the Minutes of the meeting held on 8<sup>th</sup> May, 2012.

**Agenda Item 14.02:** Action taken report of the university on the various agenda items of the 13<sup>th</sup> meeting was discussed and the members were satisfied in respect of the follow-up action being taken.

**Agenda Item 14.03:** The Council members were apprised of the powers and functions of the Academic Council as stipulated in the ACT and STATUTES of the university. The Academic Council members perused the relevant parts of the ACT and Statutes.

**Agenda Item 14.04:** The Academic Council was informed of the ORDERS of the Vice-Chancellor approving the academic calendar of the student activities, mid-term tests and last working day and end-semester examinations for the odd semester July-December 2012.

**Agenda Item 14.05:** The Academic Council was informed that the Vice-Chancellor has approved the LL. M. Regulations for the academic year 2011-13. These Regulations provide a comprehensive coverage of the LL.M. Program including the scheme of examinations and courses of study as well as evaluation.

**Agenda Item 14.06:** The Academic Council was informed of the ORDERS of the Vice-Chancellor approving the RECOMMENDATIONS of the Board of Studies in Law, regarding the syllabi for the LL.M. course 2011-13.

**Agenda Item 14.07:** The Academic Council was informed of the ORDERS of the Vice-Chancellor approving changes in course content of the papers CE705, CE706, CE502 and CE504 in Civil Engineering branch.

**Agenda Item 14.08** The Academic Council was informed of the ORDERS of the Vice-Chancellor approving the revised Regulations for the M.Tech program for session 2012-14 and onwards. . These were necessitated with a view to provide a deeper knowledge of the relevant

developments in the respective fields by incorporating FOUR theory papers in the Third Semester of the course program.

**Agenda Item 14.09:** The Academic Council was informed of the ORDERS of the Vice-Chancellor approving the revised Regulations for the Ph.D. program from the academic session 2012 and onwards.

**Agenda Item 14.10:** The Academic Council was informed of the ORDERS of the Vice-Chancellor approving the revised courses of study and the scheme of examinations for the BCA and MCA courses.

**Agenda Item 14.11:** The Academic Council considered and approved names of some more academicians to be included in the panel of experts for the selection to various teaching posts in the university.

**Agenda Item 14.12:** The Academic Council considered and approved the recommendations made by the Research Board in its meeting held on July 4, 2012.

The Council also considered the case of Mr. Mintu Kumar Yadav for his registration in Ph.D. in the field of Management. It was found that he has scored 53.88 % marks in his master's degree which does not fulfill the requirement of minimum 55% marks in master's degree as per the University Ph.D Regulations. It was unanimously resolved that Mr. Mintu Kumar Yadave may be registered for Ph.D if he improves his marks to 55 % at masters' level. However, he will not be required to appear in the Ph.D entrance test and to do the course work again.
