20.1. To consider and approve the minutes of the 19th meeting of the IQAC held on January 07, 2022.

The University as per the Strategic Planning is ready with the Roadmap (in accordance with NEP 2020) which would be the reference and base for all the academics, research and development activities. The discussions were held on the NEP features to be implemented from Academic Session 2022-23 and the Deans/HoDs will work on proposal in the light of new programs introduced and resources available.

20.6. To know the status of seed money sanctioned.

The seed money sanction notice has already been circulated and the proposals are under process.

20.7. To plan for the introduction of more Life Skill Courses in the upcoming session.

The members suggested introducing courses related to Self Defence Techniques. The suggestions were noted by IQAC and will invite more suggestions from Student Council members and other stakeholders.

20.8. To plan for the External Green Audit in the forthcoming session.

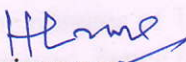
As per the University policy guidelines, the external Green Audit is due and it was decided unanimously to conduct during the next session in the month of November/December.

20.9. To discuss and plan for the Academic and Administrative Audit in the University.

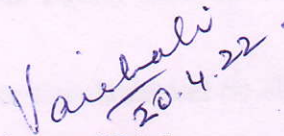
As per the discussions, the external Academic Audit is planned to be conducted in the beginning of the next academic session.
